ADMINISTRATIVE ORDER NO. 2018-039 PA/PI-CIR

**RE: GENERAL MAGISTRATES AND CHILD SUPPORT ENFORCEMENT
HEARING OFFICERS**

On August 21, 2015, June 2, 2016, and April 7, 2017, the Chief Judge of the Sixth Judicial Circuit entered Administrative Orders 2015-040, 2016-035, and 2017-020, appointing general magistrates and child support enforcement hearing officers to serve the courts. In order to update and consolidate the list of General Magistrates and Child Support Enforcement Hearing Officers that currently serve the Sixth Judicial Circuit courts, and

In accordance with Article V, section 2, Florida Constitution, Rule of Judicial Administration 2.215, and section 43.26, Florida Statutes, it is

ORDERED:

1. Each person listed in Appendix A is hereby appointed as a General Magistrate for the Sixth Judicial Circuit, in and for Pasco and Pinellas Counties, Florida, under Fla. R. Civ. P. 1.490, Fla. Prob. R. 5.095 and 5.697, Fla. R. Juv. P. 8.257 and 8.625(h), Fla. Fam. L. R. P. 12.490, sections 394.467, 397.681, and 744.369(2), Florida Statutes, and any other statutory or rule provision authorizing the appointment of a general magistrate or a general master. Each person listed in Appendix A is also hereby appointed as a Child Support Enforcement Hearing Officer pursuant to Fla. Fam. L. R. P. 12.491 for the Sixth Judicial Circuit, in and for Pasco and Pinellas Counties, Florida. The Court may amend Appendix A to appoint or remove new General Magistrates and Child Support Enforcement Hearing Officers without amending this administrative order.

2. Each general magistrate must:

- a. Take the oath of office required of officers by the Constitution of the State of Florida, and the oath will be properly recorded in the Official Records of the Clerk of the Circuit Court for Pinellas County, Florida with this administrative order. The persons listed in Appendix A who have previously executed an oath as a general master, or general magistrate, which oath was recorded with a previous Administrative Order, are not required to submit an additional oath.
- b. Perform duties in accordance with Fla. R. Civ. P. 1.490, Fla. Prob. R. 5.095 and 5.697, Fla. R. Juv. P. 8.257 and 8.625(h), Fla. Fam. L. R. P. 12.490, sections 394.467, 397.681, and 744.369(2), Florida Statutes, and any other statutory or rule provision authorizing the appointment of a general magistrate or general master, including the applicable Rules of Court and the Code of Judicial Conduct, and as provided herein.
- c. Be a member in good standing of The Florida Bar.
- d. Serve at the pleasure of the Chief Judge.
- e. Serve without posting a bond.

3. Fla. Fam. L. R. P. 12.491 continues to be invoked and child support enforcement hearing officers will continue in use in the Sixth Judicial Circuit.

4. Each child support enforcement hearing officer must:

- a. Perform duties in accordance with Rule 12.491, any other applicable Rule of Court and the Code of Judicial Conduct, statutes, and as provided herein.
- b. Consider Title IV-D and non-Title IV-D proceedings subject to funding requirements.
- c. Be a member in good standing of The Florida Bar.
- d. Serve at the pleasure of the Chief Judge and a majority of the circuit judges in the circuit.
- e. Serve without posting a bond.

5. Each general magistrate and hearing officer may take testimony and establish a record by electronic means. The record will be made, retained, and destroyed in accordance with Rule of Judicial Administration 2.430 and administrative orders governing court reporting in this circuit. If the recording is transcribed, either in whole or part, when necessary for an appeal or for further use in the trial court, the court employed or contract court reporters will be utilized for such transcribing unless otherwise provided in administrative orders governing court reporting in this circuit.

6. All actions taken before this date by the general magistrates and child support enforcement hearing officers named in this Order are hereby confirmed.

Administrative Orders 2015-040, 2016-035, and 2017-020 are hereby rescinded.
